Question 6. Are you in favor of amending the Constitution to reduce the age requirement for persons being elected to the office of state senator or executive councilor from 30 years of age to 25 years of age? (Passed by a vote of 279 Yes, 66 No)

(Passed by a vote of 297 Yes, 35 No)

Question B. Are you in favor of amending the Constitution to provide that in the event of a vacancy in the office of governor or the incapacity of the governor to perform his duties, the president of the senate, speaker of the house, secretary of state and state treasurer, in that order, shall be acting governor until the vacancy is filled or the incapacity removed; that if a vacancy in the office of governor for the remainder of the governor's term occurs before the commencement of the last year of his term, a special election for governor shall be held, that the incapacity of the governor shall be determined by his written declaration or by judgment of the supreme court; that the office of governor may be declared vacant by the general court when the governor or governor-elect has been incapacitated for a period of 6 months; and that a justice of a New Hampshire court shall administer the oath of office to the newly-elected governor? (Passed by the N.H. House 257 Yes 83 No, passed by the State Senate 21 Yes 1 No)
