Constitutional Amendments

Questions submitted to the qualified voters of New Hampshire, November 4, 1980, together with the votes on each question:

RSA 663:3 requires that all questions relating to constitutional amendments shall include the vote of the General Court or the Constitutional Convention when recorded. Questions 1 through 3 were passed by voice vote.

(Questions Relating to Constitutional Amendments Proposed by
the Convention to Revise the Constitution.)

1. Are you in favor of amending the Constitution so that references in the bill of rights to "men", "man" and "man's" are changed to "people", "person" and "person's", respectively?

2. Are you in favor of amending the Constitution by removing certain obsolete provisions and rewriting them as follows:

- (a) In Article 27, Part First, to allow "civil authorities" rather than "civil magistrates" to quarter troops in homes in times of war, subject to the control of the legislature?
- (b) In Article 43, Part Second, to eliminate "infectious distemper" as a reason for the governor to convene the legislature at a different place?
- (c) In Article 95, Part Second, to provide that all full-time, active duty members of the armed services shall be ineligible to be governor, governor's councilor, state senator or state representative and removing the provision that military officers receiving compensation for military service shall be ineligible for those offices?

3. Are you in favor of amending the Constitution to repeal Article 99 of Part Second which contains procedures for amending the Constitution now covered by Article 100 and to incorporate in Article 100 the existing provision in Article 99 for approval of constitutional amendments by two-thirds of the qualified voters present and voting on the subject?

4. Are you in favor of amending the Constitution to require all proposed constitutional amendments to be submitted to the voters at the next biennial November election following their proposal?

(Passed by the N.H. House, 332 Yes 3 No, passed State Senate, 23 Yes 0 No.)

5. Are you in favor of amending the Constitution to require a three-fifths vote by the entire membership of the constitutional convention to propose constitutional amendments?

(Passed by the N.H. House, 319 Yes 20 No, passed State Senate, 23 Yes 0 No.)

Governor's Proclamation

State Of New Hampshire Executive Department

Concord, December 10, 1980

Be it known that I, Hugh J. Gallen, Governor of the State of New Hampshire, in obedience to the request of the Constitutional Convention holden at Concord, the second Wednesday of May, 1974, and the 1979 General Court, do hereby proclaim to the people of this State that the Constitution of New Hampshire is amended as provided for in Questions No. 2, 3, 4, and 5, which were submitted by said Constitutional Convention and the 1979 General Court, to the qualified voters of the State at the meetings held in the several towns, city wards, and places in this State, on the Tuesday next following the first Monday in November, 1980.

The alteration and amendments in said Constitution covered by these questions have been approved and adopted, and the Constitution is thus amended by the suffrages of more than two-thirds of the qualified voters present at the said meetings, and voting upon the said questions.

Given under my hand and the seal of said State, at the Council Chambers, this tenth day of December, A.D., 1980, and of the Independence of the United States of America, the two hundred and fifth.

The following question was placed on the state general election ballot in those towns not having previously adopted the provisions of RSA 466:30-a (1979 Laws, Chapter 14):

"Shall we adopt the provisions of RSA 466:30-a which makes it unlawful for an owner of any dog licensed or unlicensed to allow said dog to run at large, except when accompanied by the owner or custodian, and when used for hunting, herding, supervised by competition and exhibition or training for such?"
